ABSTRACT OF LOCAL LAW ENTITLED  
“A LOCAL LAW PROVIDING A FOUR-YEAR TERM  
FOR THE ELECTIVE OFFICE OF TOWN SUPERVISOR  
OF THE TOWN OF WHITESTOWN”  
BALLOT ABSTRACT FOR GENERAL ELECTION TO BE  
HELD NOVEMBER 2, 2021

Adopted by the Town of Whitestown, New York on April 7, 2021, to be submitted as PROPOSITION NO. 1 and voted upon in the Town of Whitestown at the general election to be held on November 2, 2021.

The purpose and effect of this Local Law is to amend section 24 of the Town Law of the State of New York to provide that the term of elective office of the Town Supervisor of the Town of Whitestown shall be four years commencing January 1, 2022.

The foregoing abstract, together with a proposition herewith submitted, is prepared by the Town Clerk of the Town of Whitestown, New York, with the advice of the Town Attorney of the Town of Whitestown, pursuant to sections 10 and 25 of the Municipal Home Rule Law of the State of New York.

PROPOSITION NO. 1, submitting a Local Law for the year 2021 to the electors of the Town of Whitestown.

To be voted upon at the General Election of the Town of Whitestown, to be held on November 2, 2021.

SHALL THERE BE APPROVED AND ADOPTED IN THE TOWN OF WHITESTOWN, NEW YORK, A LOCAL LAW ENTITLED "A LOCAL LAW PROVIDING A FOUR-YEAR TERM FOR THE ELECTIVE OFFICE OF THE TOWN SUPERVISOR OF THE TOWN OF WHITESTOWN", AS ENACTED BY THE TOWN BOARD OF THE TOWN OF WHITESTOWN ON APRIL 7, 2021?.




